

MINUTES SCHOOL BOARD MEETING CHARLOTTESVILLE CITY SCHOOLS

1.1 Call to Order: Associate Superintendent Jim Henderson called the meeting to order at 5:00 p.m.

Ms. Puryear noted that Dr. Rosa Atkins, Division Superintendent, and Ms. Kim Powell, Assistant Superintendent of Finance and Operations, were not present as they were attending the Charlottesville City Council Budget Work Session.

5.1 <u>Approval of Proposed Agenda</u>: Mr. Wade made a motion, seconded by Dr. Kraft, to approve the proposed agenda. Upon a roll-call vote being taken, the motion carried with Mr. Bryant, Ms. Bryson Morsberger, Dr. Kraft, Ms. McKeever, Ms. Puryear, and Mr. Wade voting yes. 6 ayes, 0 nays.

6.1 <u>Comments from Members of the Community</u>: Charles Kendig addressed the Board with comments in support of equity and increasing the number of African-American teachers in the Division.

Mira Figueroa addressed the Board with comments in support of the Walker Upper Elementary School playground.

Eva Reid, student, addressed the Board with comments in support of the Walker Upper Elementary School playground.

Colleen Gallagher, Just Children Program at the Legal Aid Justice Center, addressed the Board noting the frequency of unfriendly school climates, urged the transparency in the allocation of resources to support equity and transparency at all schools and also improved relationships in schools.

Dede Smith addressed the Board with comments related to the impact of non-resident enrollment on school capacity.

7.1 Men Passionately Pursuing Purpose (MP3): Dr. Kendra King, Director of Student Services and Achievement, introduced Dr. Paul Harris, Assistant Professor and Counselor of Education at the Curry School of Education and Human Development; Mr. Daniel Fairley, Youth Opportunity Coordinator for the City of Charlottesville; and student participants who presented educational highlights on the Men Passionately Pursuing Purpose (MP3) program. MP3 is an initiative to help Black male student athletes be ready for college, not just eligible.

The VSBA encourages all school boards to adopt the presented proclamation. Appreciation was expressed to Leslie Thacker, Deputy Clerk, and Julia Green, Clerk.
- **8.4** National Celebration of Career and Technical Education in February: Dr. Kendra King, Director of Student Services and Achievement, presented the National Celebration of Career and Technical Education proclamation for Board information. Governor Ralph S. Northam has designated February 2020 as Career and Technical Education Month® in the Commonwealth. Across the nation, Career and Technical Education (CTE) is celebrated in February to recognize the achievements and accomplishments of CTE programs. Its theme for 2020, "Celebrate Today, Own

Tomorrow!," provides Virginia schools an opportunity to showcase success stories of excellence and communicate the crucial role that CTE plays in preparing a highly skilled workforce for Virginia's economy.

11.1 Walker Upper Elementary School Playground Update: Dr. Adam Hastings, Walker Upper Elementary School Principal, and Christa Bennett, parent/organizer, who provided an update to the Board regarding a Playground for Walker Upper Elementary School. This is a parent/community-led effort to fund improvement to the outdoor recreation space at Walker. Ms. Bennett has been working cooperatively with Parks & Recreation to explore options and plan for installation of equipment that will benefit the students at Walker for as long as the School operates in its current capacity, and could then be relocated to one Charlottesville's public housing communities.

Dr. Kraft made a motion, seconded by Mr. Bryant, to approve the installation of a playground at Walker Upper Elementary School. Upon a roll-call vote being taken, the motion carried with Mr. Bryant, Ms. Bryson Morsberger, Dr. Kraft, Ms. McKeever, Ms. Puryear, and Mr. Wade voting yes. 6 ayes, 0 nays.

- CHARLOTTESVILLE CITY BLUE RIBBON COMMISSION ON SUSTAINABLE SCHOOLS FUNDING
 - It is difficult to estimate the size of the year-to-year funding gap going forward but it appears to be somewhere between \$2-4 million a year. The size of the gap will depend on how the city economy

fares, how property assessments change, what happens to school costs and whether the state and federal governments step forward to re-assume a greater share of school costs. There will be inflation and other factors that will continue to drive school costs higher in the coming years even if no new major programs or facilities are added. NEXT STEPS

Dr. Kraft noted the importance of continued planning for the proposed preschool center and also asked if Sheila Sparks, Preschool Coordinator, will receive additional support.

Mr. Wade noted that 2.5 million of the proposed budget is for non-discretionary items.

12.1 Comments from Members of the Community: Chris Meyer addressed the Board with comments of support for looking at increasing fees in a progressive manner. He also shared his excitement in hearing about CLASS and YMCA partnership and hope they will focus on achieving zero waitlists.

Ms. McKeever announced that registration for the Summer CLASS Program will open soon and highlighted the need for early registration to ensure adequate staffing.

Becca Cole addressed the Board with comments in support of improving the registration process over what was done last year.

13.1 <u>Board Member Comments</u>: Mr. Bryant thanked those who provided public comment and those who provided educational highlights. He also provided an update on recent activities such as the VSBA Capital Conference and the MLK Celebration.

Ms. Bryson Morseberger addressed the Board noting surprise on how much of the school budget is provided by the state and highlighted efforts to advocate for school funding through the #FundOurSchools initiative. She urged the community to advocate for full funding of schools

Dr. Kraft provided an update on recent activities such as the NSBA Equity Conference and NSBA Advocacy Conference and highlighted the need for lobbying for funding at the federal level.

Ms. Puryear provided an update on recent efforts of the Piedmont Regional Education Program (PREP) to address the proposed formula change that will result in reduced funding. She also announced that the Public Education Foundation will host its annual STEM Camp at UVA during the summer.

Ms. McKeever provided an update on recent attendance at a CATEC Board meeting and the VSBA Advocacy Conference. She also noted that 70% of the school budget is funded by the City Council and how Dr. Atkins' proposed budget focuses on equity, literacy, and maintaining work force and same level or programming all around.
