



surge and spring control scenarios snow what may occur it we reduce transmission rates by 25% or down to levels seen earlier this spring, respectively. The "Fall" scenarios add the potential impact of cooler weather and the holidays.

Delta has shown that the unvaccinated population remains large enough to allow additional surges. As the Delta variant continues to spread, Charlottesville, VA will see another peak, with cases reaching 582 per week during the week ending October 17, 2021.
