- On Tuesday, January 5, 2021, Dr. Atkins, Mrs. Powell, and Dr. Baptist met with Ryan McKay, MPA, Director of Policy and Planning and COVID-19 Incident Commander. During the meeting staff offered the use of school facilities as sites for COVID-19 vaccinations

Superintendent's Recommendation for Return to Face-to-Face Learning

Action from the December 17, 2021 Board Meeting: the Board approved the Superintendent's recommendation to move forward with a Return to F2F learning using Model A (with a plan to review CDC and VDH metrics on January 7, 2021 and change course as data metrics indicated).

Factors considered when developing the Superintendent's recommendation for January 7, 2021:

- Student and Staff Safety
- Community Spread Levels
- Imminence of COVID-19 vaccinations for school personnel

Recommendation

February 22, 2021 - Return to F2F learning using Model A

Option A Elementary (PreK-6)

In-Person Cohort:

- All PK-2 (who selected to come back)
 - Critical years for building foundational skills in literacy
- Grades 3-6 Tier 3, ELL Levels 1-2, select students with IEPs (team-based decision)
 - Prioritize in-person learning for students with the most critical academic needs
- Estimated in-person enrollment:
 - Grades 3 & 4: 55-85
 - Grades 5 & 6: 55-85
