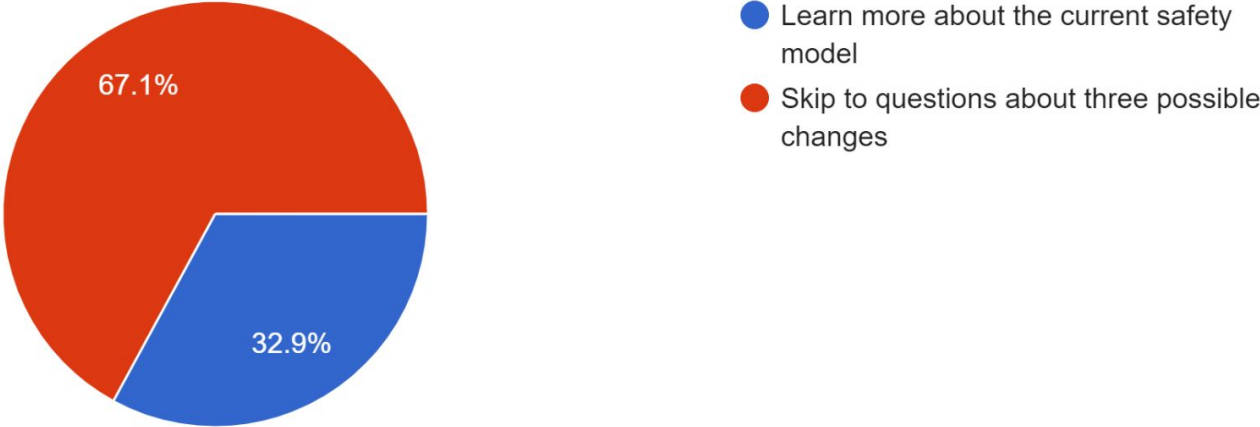

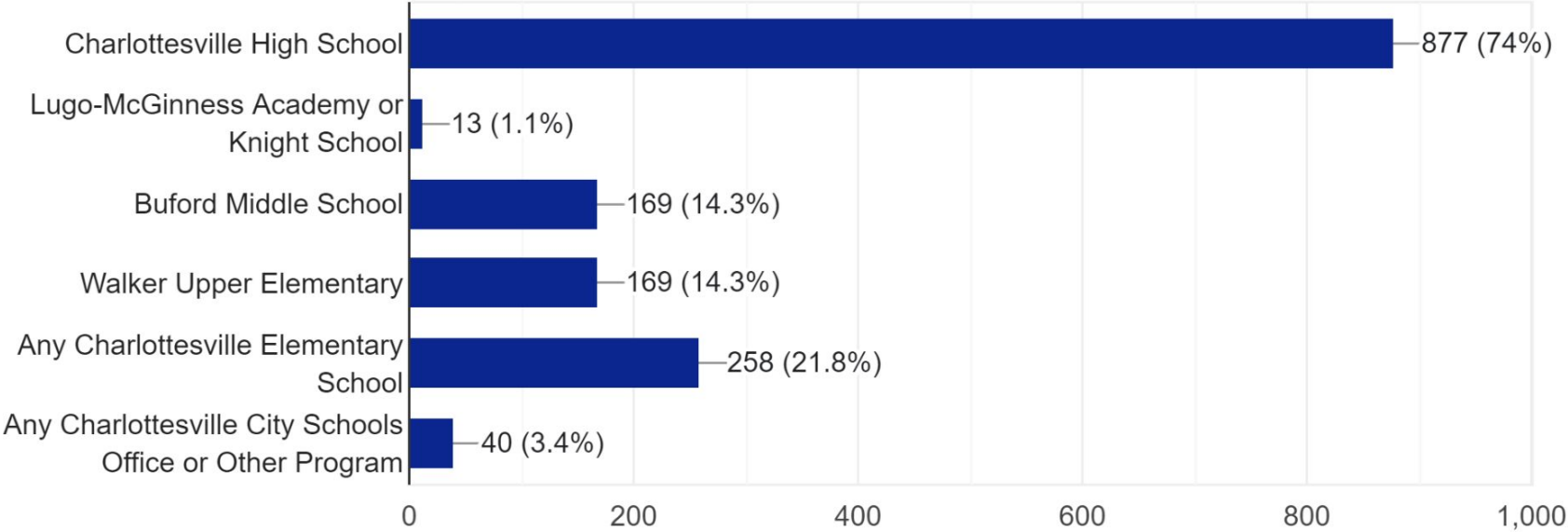

School(s) where you or your student(s) learn or work:

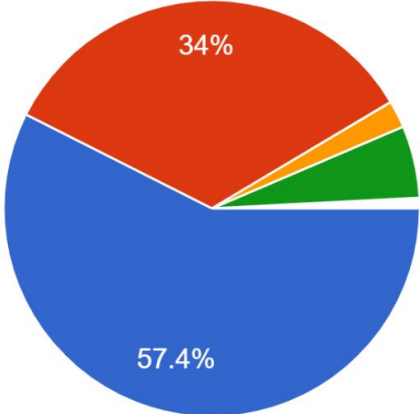

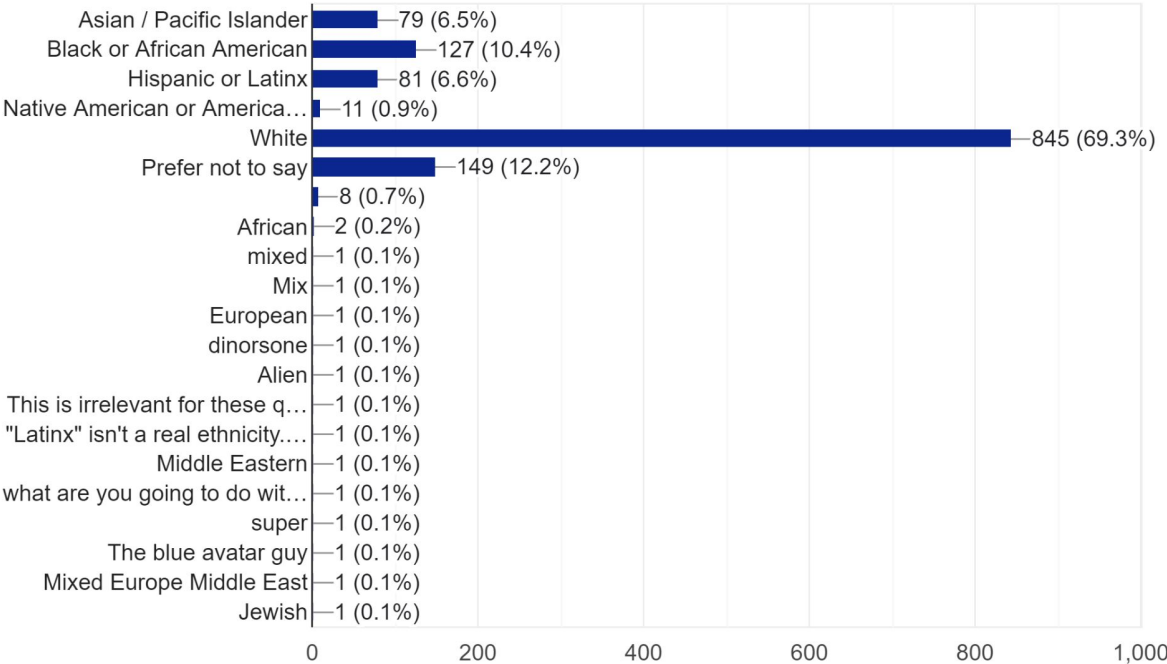

Your Ethnicity and Race

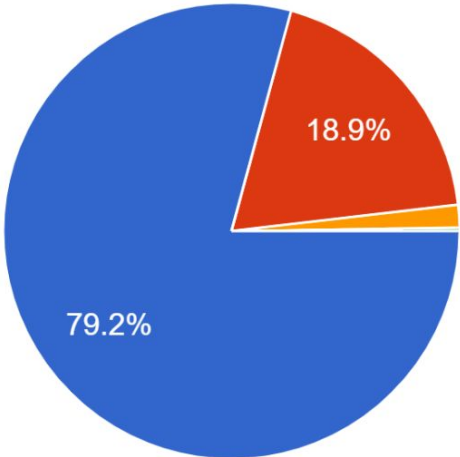

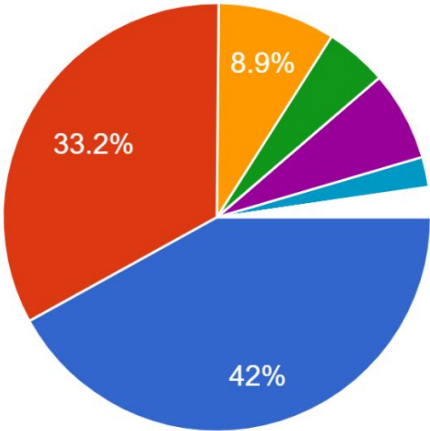

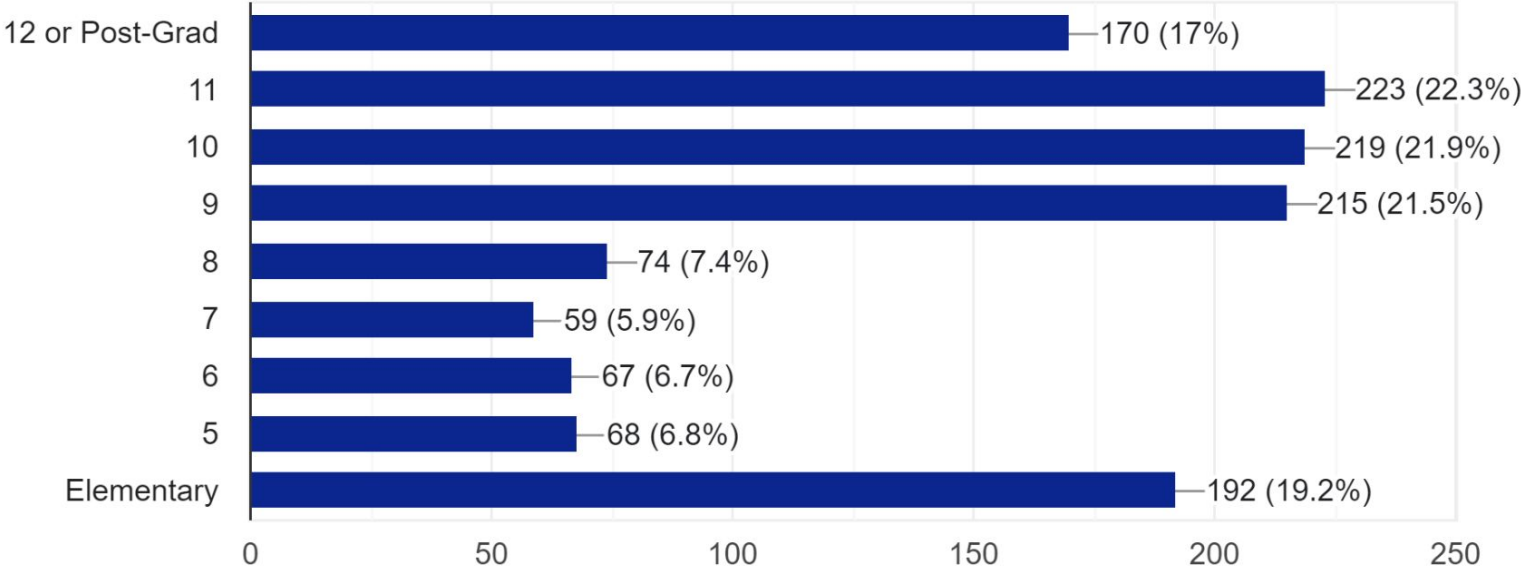

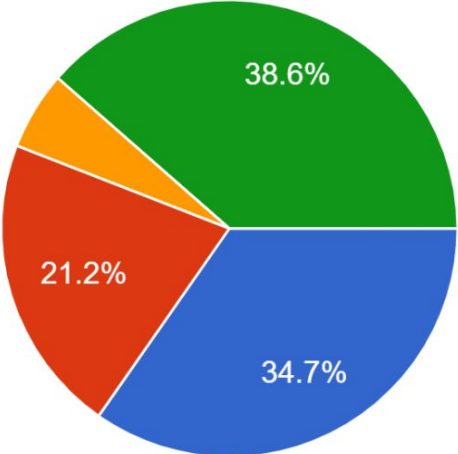

Survey Comments - Weapons Detection

Major Themes:

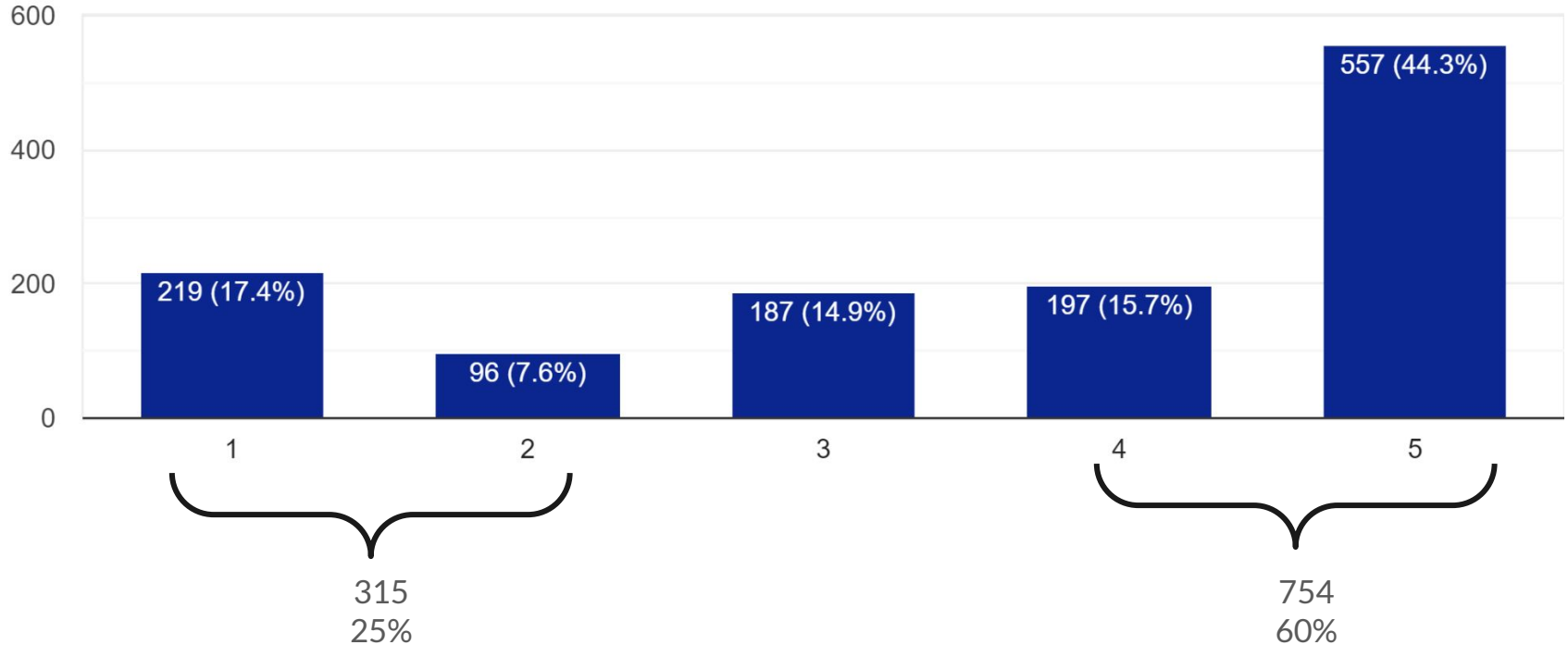
- **Doubt about the Effectiveness of Metal Detectors** to address safety concerns in schools.
- **Concerns about Increased Gun Violence** in the surrounding area merits consideration of metal detectors for high school and potentially middle school levels.
- **Alternative Safety Measures** should focus on other safety measures or addressing underlying issues contributing to violence, such as improving door security and increasing mental health support.
- **Cultural and Environmental Concerns** that metal detectors may create a culture of distrust and fear, and that their implementation could lead to a prison-like atmosphere within schools.

Survey Comments - Resource Officers

Major Themes:

From Supporters:

- **Support for students involved in the legal system**, in addition to providing daily safety support.
- **Emphasize the need for special training** to effectively engage with students and build trust.
- **Mixed feelings about armed officers** - Some see value in having armed officers for daily safety and to prevent potential threats, other prefer they not carry guns or wear quasi-military uniforms to minimize intimidation.
- **Positive experiences with resource officers** in the past highlight their role beyond just preventing fights.
- **Mentorship opportunities**
- **Essential for school safety**

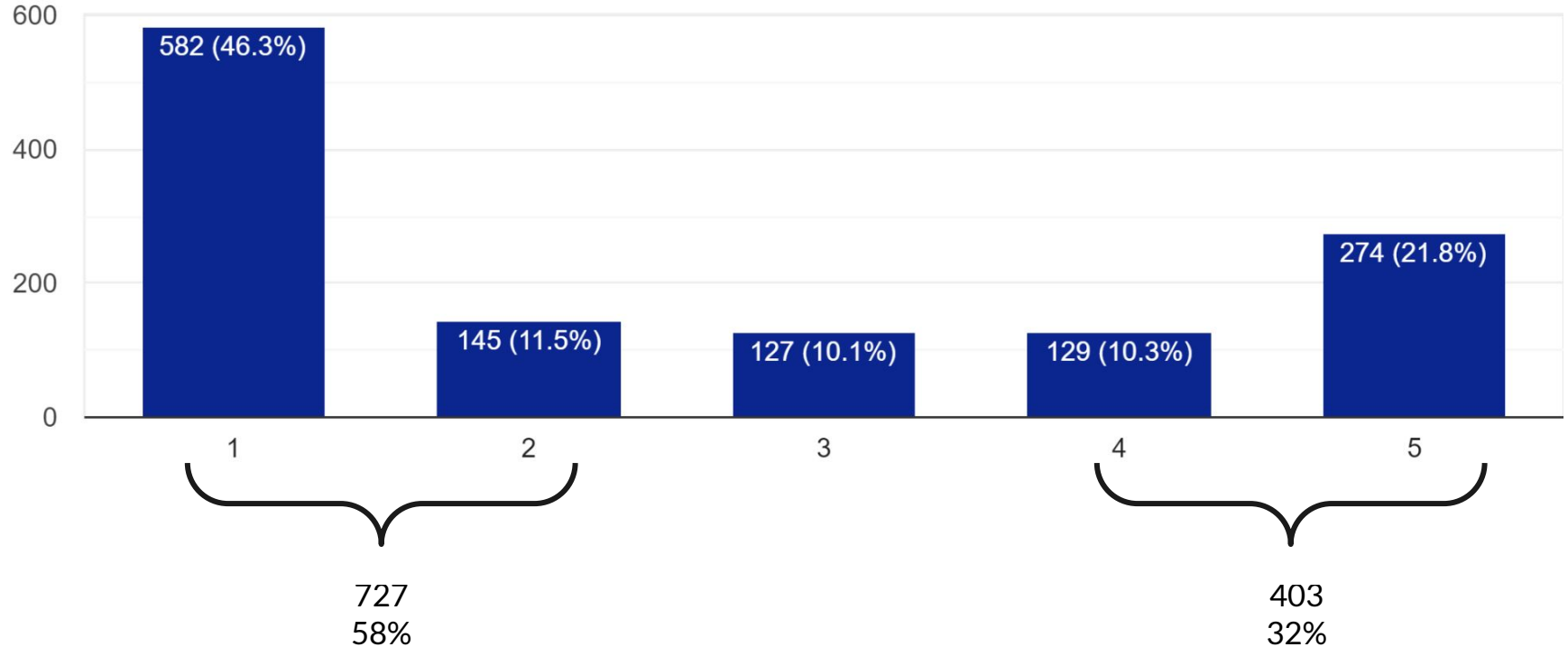
From Opponents:

- **Perpetuating the school-to-prison pipeline and exacerbating discipline disparities** affecting marginalized students.
- **Suggestions for alternative approaches** focusing on prevention, restorative justice, and increased mental health resources rather than relying solely on law enforcement.
- **Distrust of police presence** includes skepticism about traditional police involvement in schools due to concerns about racial profiling, negative interactions with students, and perpetuating a culture of fear.
- **Questioning the necessity and cost-effectiveness**, including concerns about the effectiveness of SROs in addressing underlying issues such as inconsistent administration and discipline policies.
- **Unnecessary or even detrimental**

Survey Comments - Cell Phones

Major Themes:

- **Recognition of the challenges posed by cell phones in classrooms**, including distraction and difficulty enforcing policies.
- **Concerns about the impact of cell phone use on student relationships, mental health, and learning.**
- Suggestions for implementing **stricter policies or designated phone-free zones to mitigate distractions.**
- Suggestions for designated times or spaces for cell phone use to **balance learning and student autonomy.**
- **Concerns about enforcing cell phone policies**, especially regarding students abusing the rules and potential confrontations with teachers.
- **Recognition of the utility of cell phones for communication between students and parents**, particularly during emergencies or for managing mental health issues.
- **Concerns about distraction and cyberbullying**

While opinions on cell phone policies vary, with some favoring stricter enforcement and others proposing greater leniency during specific times, there is a widespread agreement that cell phones serve as both a potential distraction and a valuable tool for safety.

Updates/Changes Week of March 4th -

The CHS survey push on March 4th resulted in 129 additional student survey participants. Input was received by over 420 students and now represents over 30% of the responses. Below is a summary of how the data shifted for each of the three areas under consideration:

- Support for weapons detection at both arrival and sporting events decreased from 44% to 39%, the “not at all” and arrival only percentages remained basically the same; however, support for weapons detection “at sporting events only” changed from 8% to 15%.
- The percentage of respondents not interested in reevaluating the role of resource officers in the CCS safety model remained at ~25%. The percentage of those interested in revisiting the role of resource officers decreased from 68% to 60%, while the percentage of those undecided in the middle (the 3’s) increased from 8% to 15%.
- The percentage of respondents who favored allowing cell phone use between classes and at lunches increased from 47% to 58%, while those favoring “off and away for the day” decreased from 41% to 32%, and the percentage of those in the middle dipped slightly from 12% to 10%.

RECOMMENDATIONS - NEXT STEPS



RECOMMENDATIONS & RATIONALE

- **Proceed with purchase of Ceia Opengate detection system to be used primarily for athletic competitions** (cost of ~\$40,000 for 2 gates can be funded from existing budget for safety/security equipment)
 - Consistent with police recommendations to area high schools along with the clear bag policy that has already been implemented
 - Consistent with what students & families experience at other sporting and entertainment events
 - Can be managed without significant changes or additions to event staffing
 - Responds to concerns for prevalence of weapons in the community and the fact that attendees at school events are not restricted to members of the school community
 - If there are multiple events being hosted at the CHS gym, auditorium and/or stadium on the same night, gates will be at the event with the largest anticipated attendance or split between events


RECOMMENDATIONS & RATIONALE

- **Proceed with learning more about the Youth Resource Officer model in Cambridge**
 - Current survey data is clear on this question.
 - Consistent with the local data from the 2020-2021 Superintendent's Committee on School Safety/Security Resources which indicated widespread support to proceed with a new model that would include resource officers:

- **Determine the optimal model for officer involvement in CCS school safety moving forward**
 - Address inefficiencies that make it more difficult for administration to meet legal requirements while managing all other aspects of the building
 - Prioritize systems thinking above the feelings or perspectives of any particular group/individuals
 - Identify and restore essential elements of the prior SRO model that were beneficial to students and families, while also taking lessons learned from the past and present to ensure potential pitfalls are avoided
 - Removing officers from CCS schools did not remove CPD from the safety model

RECOMMENDATIONS & RATIONALE

- **Maintain the current practice of “off and away DURING CLASS”**
 - Align policy with the preponderance of actual current practices
 - Refine practices and ensure consistent enforcement
 - Promote a mutual accountability ecosystem
 - Consistent student expectations
 - Admin will continue to support teachers & students in managing the expectations
 - Student agency to regulate in-class & out-of-class expectations
 - Provide additional supports for staff who are struggling with students not responding to Tier 2 and Tier 3 interventions
- **Create a standing working group of diverse students, staff, and administration to focus on school climate/culture**
 - Monitor school climate using existing data and other sources
 - Include specific initiatives around the impacts of cell phone/screen time and extend this education/outreach to middle and elementary students
 - Spear head activities to continuously improve climate/culture, helping everyone to have a sense of belonging

PROPOSED NEXT STEPS

- 
- 1. Purchase the recommended detection equipment, schedule training and review policy related to searches**
 - 2. Work with CPD to schedule the visit to Cambridge, MA to get additional information regarding that model**
 - 3. Update the Cell Phone Policy and form the working group for CHS climate & culture**

- These three areas draw out varying (often polar opposite) perspectives from our stakeholders.
- Keep in mind our shared commitments to safety, community, mental health, and partnership.
